## subject: Request for a Revised Notice of Withdrawal

On December 17 and 18, 2020, Amazon Data Services, Inc. (Applicant) submitted an application for a small power plant exemption (SPPE) for the Gilroy Backup Generating Facility (Application).<sup>1</sup>

On February 9, 2022, counsel for Applicant filed a Notice of Withdrawal of the Application.<sup>2</sup> The truth and accuracy of the contents of the Notice to Withdraw were verified under penalty of perjury by Applicant's counsel.

Section 1936(e) permits an applicant to withdraw an application as set forth in Section 1709.8. Section 1709.8 states that the notice of withdrawal must be authorized and verified in the same manner as the original notice or application, as provided in Section 1707.<sup>3</sup> Section 1707 in turn requires verification by the Applicant rather than its counsel.

Upon receipt of a withdrawal verified by the Applicant, the Presiding Member shall immediately issue a written order to terminate the application proceeding and close the docket.<sup>4</sup>
