As part of the 2022 Integrated Energy Policy Report Update (2022 IEPR Update) proceeding, the California Energy Commission (CEC) will host a workshop to present the proposed scope and timeline for the implementation of the California Planning Library. The aim of the California Planning Library is to centrally locate and make readily accessible the various energy planning tools developed by the CEC and widely used by stakeholders. The workshop will be led by Vice Chair Siva Gunda, the CEC's Lead Commissioner for the *2022 IEPR Update*. A quorum of commissioners may participate in person, but no votes will be taken.

The public can participate in the workshop consistent with the direction provided below. Please note that the CEC aims to begin promptly at the start time posted and the end time is an estimate based on the agenda proposed. The workshop may end sooner or later than the posted end time depending on various factors.

Agenda

CEC staff will present the proposed concept, scope, and timeline for the implementation of the California Planning Library. Representatives from state government, industry, research groups, and other interested stakeholders will participate in a panel discussion about the California Planning Library. Discussion will address priority data sets and deliverables to include and how to maximize the accessibility of those products.

Background

CEC analytical products serve as critical tools for state agencies and energy system stakeholders as they plan investments and make legislative and regulatory decisions. As described in the [Draft Scoping Order for the 2022 IEPR Update](#) at <https://www.energy.ca.gov/data-reports/reports/integrated-energy-policy-report/2022-integrated-energy-policy-report-update>, the CEC will develop a platform within the CEC public website to identify, organize, and publish data sets and deliverables widely used by stakeholders. The CEC will consolidate, integrate, and enhance the following analytical products into a California Planning Library:

- Energy demand forecasts and scenarios including:

- Updated end-user electricity, gas, and transportation fuel demand forecasts to 2035.
- Energy demand scenarios to assess long-term (to 2050) decarbonization policy impacts on electricity and gas demand forecast. These scenarios will support future SB 100 analyses as well as inform policy driven procurement and investment decisions.
- Reliability assessments.
- Land-use screens.
- Other analytical resources, including those developed under active CEC informational proceedings and other CEC proceedings.

CEC staff will solicit input on the development of the California Planning Library. Further, CEC staff will work with internal technical experts to identify data sets and deliverables that are readily available for immediate inclusion in the California Planning Library, as well as those which will require dedicated staff resources to develop. Finally, CEC staff will outline a phased approach to develop, implement, and update the California Planning Library to maximize its use and effectiveness.

Public Comment

Oral comments will be accepted at the workshop. Comments may be limited to three minutes or less per speaker and one person per organization. Depending on the number of members of the public seeking to make a comment, the facilitator may adjust the total time allotted for public comment and the time allotted for each comment.

If participating via Zoom’s online platform, use the “raise hand” feature to alert the administrator that you would like to make a comment after the lead commissioner opens the floor for public comment.

If participating by telephone, press *9 to “raise your hand” and *6 to mute/unmute. A workshop administrator will call on you by the last three digits of your phone number. Unmute your phone before introducing yourself and sharing your comment.

The Public Advisor may, upon the request of public participants who may be absent during the workshop when a matter of interest to them is being discussed, neutrally and publicly relate those participants’ points to the CEC on behalf of the public. Comments submitted after the workshop starts will be filed in the workshop docket.
