The 2019 Building Energy Efficiency Standards (Energy Code) allows a registration provider to use an external digital data source (EDDS) service as an alternative to keyed-in data entry for authorized users of its data registry. The registration provider must apply to the California Energy Commission (CEC) for approval to make use of the service (Title 24, Part 6, Reference Joint Appendix JA7).

ConSol Home Energy Efficiency Rating Services (CHEERS), Inc., a CEC-approved registration provider, applied to use Archon Energy Solutions Compass EDDS service with the associated data registry on July 20, 2021. Additional information and revisions to the application were submitted by the registration provider on December 10, 2021 and on February 8, 2022. A public comment period and staff workshop were also held to gather additional information on the application from interested stakeholders.

Staff has evaluated the complete EDDS application, additional information, and live demonstration of the EDDS features. Based on these evaluations, staff has found that the application complies with all applicable requirements in the 2019 Energy Code. Staff recommends that the executive director approve the CHEERS application to use Archon Energy Solutions Compass EDDS service.
