# Incentives and Investments to Facilitate lithium Extraction from Geothermal Brines and Development of Lithium-Dependent Products and Businesses Workshop

- Discussion of Agenda Topics and Presentations for Future Meetings
  - Overcoming Challenges to Lithium Extraction Workshop
    - Commissioner Hanks and Commissioner Ruiz presented their ideas for the upcoming workshop on Overcoming Challenges to Lithium Extraction which was followed by discussion among the Commissioners
  - Chair Paz also requested that the sub-body planning the workshop exploring the Potential Benefits of and Added Value to Existing and New Geothermal Facilities in Areas that Contain Mineral Rich Brines for the State, the Western Energy Grid, and the United States, Including but Not Limited to Grid Stability, Reliability, and Resiliency

- Commissioner Hanks presented ideas on the upcoming workshop of which was followed by discussion among the Commissioners
- Chair Paz requested CEC staff assist the members of both sub-bodies that provided reports and consider holding the two workshops on the same day or possibly combining both workshops.
- Tribal Panel
  - Chair Paz gave a brief update on planning for a possible Tribal panel or other options to hear from Tribal communities noting she will continue to coordinate with Commissioner Scott and Commissioner Lopez to explore
- Continuation of Environmental Impacts Workshop
  - Chair Paz recommended that the Continuation of Environmental Impacts Workshop specifically address waste streams that are associated with the lithium extraction facilities planned and in development, possibly the exploration of environmental considerations in the Salton Sea region as well as other topics of interest to Commissioners, which was followed by discussion among the Commissioners
- Future Meeting Schedule and Locations
  - o Chair Paz recommended the following future meeting dates and plans:
    - June 16<sup>th</sup> at 1:00 PM, to conduct the Overcoming Challenges to Lithium Extraction Workshop, Role of Existing and New Geothermal Facilities in the Salton Sea Region to Support Reliability, Grid Stability, Resiliency and Clean Energy Goals Workshop, and possibly receive an update on the state budget
    - June 30<sup>th</sup> at 1:30 PM to focus on the Continuation of Environmental Impacts Workshop
    - July 21<sup>st</sup> to be a full day meeting from 9:30 AM to 5:00 PM and anticipates the meeting to be on the draft report.
    - August 25<sup>th</sup> to be a full day meeting from 9:30 AM to 5:00 PM, expected discussion on the final report
    - The September meeting, anticipated for approval of the final report, is scheduled for September 15<sup>th</sup> to support completing submittal to the Legislature by the statutory deadline.

letter is dated April 26, addressed to the Lithium Valley Commission, and sent by the Peoples Collective for Environmental Justice, San Pedro & Peninsula Homeowners Coalition, Center for Community Action and Environmental Justice and others. Chair Paz requested the CEC explore options to either acknowledge receipt or respond to the letters.
