The California Energy Commission (CEC) staff will host a remote access workshop for the Demand Side Grid Support (DSGS) Program's Draft Guidelines (Draft Guidelines). The DSGS program will provide incentives to reduce customer net energy load during extreme events. The Draft Guidelines propose the rules for the program, including eligibility requirements, participation process, incentive structure, and the payment process.

The workshop will be held remotely. The public can participate in the workshop by following the direction provided below. CEC staff aims to begin promptly at the start time posted and the end time is an estimate based on the proposed agenda. The workshop may end sooner or later than the posted end time depending on various factors.

Agenda

During this workshop, staff will present the CEC's proposed requirements for DSGS Program participation, including eligibility, enrollment documentation, DSGS incentive structures, and the payment process.

Background

Created by [Assembly Bill \(AB\) 205](#) (Ting, Chapter 61, Statutes of 2022) as part of the Strategic Electricity Reliability Reserve, the DSGS program will compensate eligible participants enrolled with their electric retail supplier (DSGS provider) for upfront capacity commitments and for per-unit reductions in net load during extreme events achieved through reduced usage and/or use of backup generation.
