Background

Created by Assembly Bill (AB) 205 (Ting, Chapter 61, Statutes of 2022) as part of the Strategic Reliability Reserve, the DSGS program will compensate eligible participants enrolled with their electric retail supplier (DSGS provider) for upfront capacity commitments and for per-unit reductions in net load during extreme events achieved through reduced usage or use of backup generation or both.

The proposed DSGS Program Guidelines were initially presented at a July 25, 2022, workshop followed by a written comment period. Proposed revisions to the document are contained in the proposed DSGS Program Guidelines and shown in underline/strikethrough format with proposed language appearing in underline and proposed deletions appearing in strikethrough.
