Dear Docket Unit:

I am writing on behalf of ICF, a program administrator for the California Advanced Lighting Controls Training Program ("CALCTP") ("Applicant") to resubmit this repeated application¹ for confidential designation of certain specified Acceptance Test Curriculum Materials, CALCTP compliance forms, and Test Questions as 2022 amendments to CALCTP's Acceptance Test Technician Certification Provider Application to become a Lighting Control Acceptance Test Technician Certification Provider under California Code of Regulations, Title 24, Part 6, § 10-103-A ("Amended Lighting Control ATTCP Application"). These documents are submitted under Docket 13-ATTCP-01.

The materials submitted contain revisions and edits to the 2013, 2016 and 2019 submittals, and are thus substantially similar to the previously submitted information and all facts and circumstances relevant for confidentiality remain unchanged. Therefore, the June 26, 2022 and August 4, 2022 amended application materials should be designated as confidential under the repeated application provision of the Commission's Title 20 regulations.²
