The California Energy Commission (CEC) and the California Department of Transportation (Caltrans) will host a workshop to present and solicit feedback on the proposed structure, requirements, and eligibility for the National Electric Vehicle Infrastructure Funding Program (NEVI) grant funding opportunity.

The public can participate in the workshop sessions consistent with the attendance instructions below. The CEC aims to begin promptly at the start time posted and the end time is an estimate based on the proposed agenda. The workshop may end sooner or later than the posted end time.

Agenda

Session 1 will include a staff presentation on the proposed structure, eligibility, and requirements for the NEVI grant funding opportunity. Discussion topics include the eligible corridor segments, ranking of the corridor segments, minimum power levels for the chargers, match share requirements, and application evaluation criteria.

Session 2 will include a staff presentation on the methodology for the corridor segment prioritization which will be followed by a public discussion period. The goal of this session is to solicit feedback on the proposed methodology for prioritizing the corridor segments.

Background

NEVI provides \$5 billion in formula grant funding to the states as part of the 2021 federal Infrastructure Investment and Jobs Act (IIJA). California's share is expected to be \$384 million, allocated over 5 years. The primary policy objective for NEVI is to establish a coast-to-coast network of 500,000 modern, high-powered direct current (DC) fast chargers along the nation's freeways and highways to enable long-distance travel in zero-emission vehicles.

The NEVI program designates Caltrans as the lead agency for California. Caltrans and the CEC are collaborating on program design and implementation. This workshop will share the structure and requirements that have been developed to implement the grant funding opportunity to deploy high-powered DC fast chargers along California's corridors.
