San Diego Community Power ("SDCP") requests the California Energy Commission ("Commission") designate the information included in SDCP's 2023 Electricity Resource Planning Forms S-1, S-2, S-2A, and S-5 as confidential pursuant to Title 20, Cal. Code. Regs. ("CCR") Section 2505 et seq. and the justifications set forth below. These forms were submitted to the CEC on September 9, 2022 in the Microsoft Excel document titled "CONFIDENTIAL_San Diego Community Power_IEPR 2023-Electricity Resource Plan Template_22-IEPR-03" that contains six Excel sheets. In accordance with the CEC's Forms and Instructions for Submitting Electricity Resource Plans, SDCP provides the following information in support of its application for confidentiality designation.

Description and Identification of Confidential Information

SDCP seeks confidential treatment of the following information in Electricity Resource Plan Form S-1:

• Capacity Procurement Requirement Peak Load Calculations for years 2022-2031 (sheet S-1_REQUIREMENT, cells 11I-S, 19I-S, 20I-S, 21I-S, 22I-S, and 25I-S)

SDCP seeks confidential treatment of the following information in Electricity Resource Plan Form S-2:

- Total Renewable Contract Supply (sheet "S-2 SUPPLY," lines 32-62, columns P-Y)
- Other Bilateral Contract Supply (sheet "S-2_SUPPLY," lines 64-265, columns P-Y and AC-AL)

- Capacity/Energy Balance Summary (sheet "S-2_SUPPLY," lines 270-275, columns P-Y and AC-AL)
- Notes (sheet "S-2_SUPPLY, cell 179B)

SDCP seeks confidential treatment of the following information in Electricity Resource Plan Form S-2A:

Forecasted Contracted GWh (sheet "S-2A_Addendum Monthly," lines 10-43, columns F-DU)

SDCP seeks confidential treatment of the following information in Electricity Resource Plan Form S-5:

• Capacity (MW) Under Contract (sheet "S-5 Table," cells 9I-195I)

Length of Time the Information Should Be Kept Confidential

SDCP requests that the Commission keep SDCP's information confidential and protected from public disclosure for a period of 3 years. This length of time is needed to ensure that SDCP's detailed load forecast data in Form S-1 and market position information in Form S-2, S-2A, and S-5 remains secure from market participants that could make competitive use of this information to the detriment of SDCP, SDCP's ratepayers, and the electricity market as a whole. Further, this length of time is consistent with how the Commission has treated similar information.¹

Provisions of Law Allowing the Commission to Keep the Documentation Confidential

The California Code of Regulations provides that an application for confidentiality shall be granted where an applicant makes a reasonable claim that the Public Records Act or other provision of law authorizes the Commission to keep the records confidential.² The Public Records Act exempts from disclosure records that are exempted pursuant to state law, including provisions of the Evidence Code.³ The Evidence Code provides a privilege for trade secrets and allows the owner of a trade secret to prevent another from disclosing it.⁴ In an analogous context, "trade secrets" has been defined to include "information, including a formula, pattern, compilation, program, device, method, technique, or process, that... [d]erives independent economic value, actual or potential, from not being generally known to the public or to other persons who can obtain economic value from its disclosure or use..."⁵ Further, the Commission's regulations provide for information to be designated as confidential if it "contains a trade secret or its disclosure would otherwise cause a loss of a competitive advantage."⁶

SDCP requests that the identified portions of Form S-1, S-2, S-2A, and S-5 are kept confidential because they contain trade secret information and information that would otherwise cause a loss of a competitive advantage to SDCP. The forecasted load and supply data in these Forms would reveal SDCP's expected market position for resource adequacy capacity and energy. This information, if publicly known, could be used by competitors to cause competitive harm to SDCP by undermining SDCP's negotiating position, both as a buyer and a seller.

The Public Records Act also permits the Commission to withhold any record where the public interest served by not disclosing the record clearly outweighs the public interest served by disclosure of the record.⁷ Thus, even if there were no trade secret exemption, there is still a separate basis for not publicly-releasing SDCP's confidential information, since the disclosure of the information has the potential to undermine SDCP's market position and disrupt energy markets more generally.

Data Aggregation

The data in question can be disclosed if it is aggregated with other LSEs' forecast and supply information at a level that does not permit SDCP's confidential information to be derived from the aggregated data.

The Submitted Information Is Presently Confidential

SDCP does not publicly disclose forecasted energy and capacity positions. SDCP considers such information market sensitive, as public disclosure of this information could compromise SDCP's competitive position in the electricity market. Further, to the extent similar information is disclosed to other regulatory agencies (e.g., the California Public Utilities Commission), SDCP seeks protection of this information from public disclosure in those forums. SDCP's confidential information can be disclosed if it is aggregated with other load serving entities' information at a level that does not permit SDCP's confidential information to be derived from the aggregated data.
