The information submitted is substantially similar to information included in CCCE's 2021 Electricity Resource Plan (S-1, S-2 and S-5) filings. All the facts and circumstances relevant to confidentiality remain unchanged. (California Code of Regulations, title 20, Section 2505(a)(4).) CCCE also asserts confidentiality under Section 2505(b) as a local agency which possesses information pertinent to the responsibilities of the CEC, that has been designated by CCCE as confidential under the Public Records Act. Finally, the confidential records contain highly market sensitive and trade secret information. If publicly disclosed, the information would undermine CCCE's negotiating position and disrupt functioning energy and capacity markets. Conversely, there is little public interest in disclosure of CCCE's specific, non-aggregated data.

4. State whether the information or data can be disclosed if it is aggregated with other information or masked to conceal certain portions (including but not limited to the identity of the applicant). State the degree of aggregation or masking required. If the data cannot be disclosed even if aggregated or masked, explain why.

The data in question can be disclosed if it is aggregated with other LSE's forecast and supply information at a level that does not permit CCCE's confidential information to be derived from the aggregated data.

CCCE does not publicly disclose detailed load forecast data or detailed capacity and energy market positions. CCCE only provides this information as requested or required by regulatory agencies and in doing so seeks confidential protection of such information.
