Pursuant to COM-4, and as part of Geysers Power Company's ("GPC") ongoing efforts to keep the Energy Commission informed of fire system recommissioning activities at the Geysers, GPC is providing this report summarizing the recommissioning activities at Sonoma, Unit 3 (80-AFC-01C), Lakeview, Unit 17 (79-AFC-03C), and Calistoga, Unit 19 (81-AFC-01C), collectively referred to herein as "the Geysers." This report covers recommissioning activities during August 2022 (August 1 - 31, 2022) and provides recommissioning schedule updates.

1. Fire Protection Project Status

The Fire Protection Recommissioning project at the Geysers continued in the month of August 2022. GPC continues to work with its consultant, GHD, and CEC staff in revising the final Basis of Design Narratives ("BOD") and Recommissioning ("ReCx") Plans for the remaining plants in response to CEC comments received on previously submitted documents. In August, GPC submitted confidential comments logs showing how submitted BODs were revised to be responsive to CEC comments.
