Subject: STATUS REPORT #1 AND RESPONSE TO COMMITTEE QUESTIONS FOR THE STACK TRADE ZONE PARK SMALL POWER PLANT EXEMPTION (21-SPPE-02)

In its September 16, 2022, *Committee Scheduling Order and Order Requesting Supplemental Information*, the Committee directed all parties to respond to three questions regarding a water supply assessment and file responses in the docket with the parties first status report no later than 5:00 p.m. on September 28, 2022 (TN 246119). This portion of the order (page 5) has since been vacated in the Committee's *Order Vacating Request for Supplemental Information Regarding Water Supply Assessment* (TN 24200). The Committee also ordered the parties to file monthly status reports on September 28, 2022, and no later than the 28th day of every month thereafter.

Project Status

After filing our *Issues Identification Report, Status Report, and Proposed Schedule* on July 20, 2022, staff filed a second set of data requests and plans on submitting a third. Staff filed Data Requests Set 1 on May 16, 2022, and Data Requests Set 2 on July 20, 2022. Staff has been reviewing all materials submitted by the applicant, including the recently filed Revised Project Description. The applicant has filed partial responses to Set 1 and Set 2. Specifically, staff is awaiting complete responses from Set 1, numbers 4, 5, 26 a, 29, 30, 32, 37, 49 to 51, 54 to 56 a and b, 58 and from Set 2, numbers 79, 80, 81, 82 a through d, and 91.

As the project meets the definition of a *project of statewide, regional, or areawide significance* under California Environmental Quality Act (CEQA) Guidelines, section 15206 (b)(2)(E), staff will conduct a scoping meeting for the environmental impact report (EIR) as required by CEQA Guidelines, section 15082 (c)(1). Staff will file a public notice of the EIR scoping meeting in the project's docket at least 10 days in advance of the meeting.
