The California Energy Commission (CEC) will host a remote workshop to discuss the applicant's objections to various CEC staff data requests for the Willow Rock Energy Storage Center (WRESC) project. The purpose of this workshop is to clarify the applicant's objections, seek compromise on acceptable responses, and ideally limit the number and scope of issues to be presented to the Committee¹ in a potential motion to compel a response by staff. The public can participate in the workshop consistent with the attendance instructions below.

Background

CEC staff is currently engaged in discovery efforts as part of its analysis of the Application for Certification (AFC) for the WRESC. CEC staff docketed Data Requests Set 1 on July 26, 2022. In a filing dated August 15, 2022, the applicant objected to various data requests from Set 1, including data requests in the topic areas of Alternatives, Biological Resources, Geological Resources, Land Use, and Transmission System Engineering. In its scheduling order filed August 26, 2022, the Committee advised CEC staff and the applicant to hold a workshop to discuss and seek resolution on applicant's objections, and to subsequently submit a joint filing capturing any agreements reached by the parties.

¹ The Committee consists of two CEC Commissioners assigned to oversee the WRESC proceeding. Commissioner Kourtney Vaccaro is the Presiding Member and Commissioner Andrew McAllister is the Associate Member.

The workshop will generally consist of discussions between CEC technical staff and representatives of the applicant to clarify the reasonable basis for staff data requests and the grounds for applicant's objections. The order of topics to be discussed will be set (and may change) based on the availability of technical staff and representatives of affected stakeholder agencies. Although it was not part of the direction included in the Committee's scheduling order, the applicant has also requested an opportunity to discuss the overall proceeding schedule and staff's intention to file a motion extending the discovery period—this will be accommodated to the degree that time allows. Staff and the applicant will also need to discuss the logistics associated with preparing a joint filing describing the outcome of the workshop, including any agreements reached at the workshop to resolve the applicant's objections, as directed by the Committee in the scheduling order.

Given the number of data requests being objected to and their grouping by technical area, it is difficult to predict the overall duration of the workshop. The CEC aims to begin promptly at the start time posted. The end time is an estimate based on the anticipated topics of discussion--the workshop may end sooner than the posted end time. Should additional time be needed to complete the agenda beyond the allotted five hours (including a break for lunch), the workshop would likely be continued to a subsequent date.
