The California Energy Commission (CEC) will host a remote-access workshop to discuss labor and workforce topics and to gather information for the CEC's second Assembly Bill (AB) 2127 assessment. The workshop will solicit public feedback to inform the assessment. A quorum of commissioners may participate, but no votes will be taken.

The public can participate in the workshop consistent with the instructions provided below. The CEC aims to begin promptly at the start time posted and the end time is an estimate based on the proposed agenda. The workshop may end sooner or later than the posted end time.

The workshop will include a staff presentation on labor and workforce issues that may be addressed in the second AB 2127 assessment, including panel discussions by workforce training practitioners and subject matter experts, followed by a question and comment period with the public.

Background

AB 2127 (Ting, Chapter 365, Statutes of 2018) requires the CEC to biennially assess the electric vehicle (EV) charging infrastructure needed to meet the state's goals of putting at least 5 million zero-emission vehicles (ZEVs) on California roads by 2030 and reducing greenhouse gas emissions to 40 percent below 1990 levels by 2030. On September 23, 2020, Governor Gavin Newsom signed Executive Order N-79-20, which directed the CEC to update this assessment to support expanded ZEV adoption targets.

The inaugural AB 2127 assessment was published in July 2021, and the CEC is currently developing the second assessment. A key component to the assessment is charging infrastructure analysis to support EV adoption. The inaugural assessment also introduced workforce as a factor to be considered with regards to charging infrastructure deployment.

This workshop will focus solely on labor and workforce issues that support the EV charging infrastructure ecosystem. Staff will introduce a range of topics that may be considered in the second assessment, facilitate question and answer discussion with workforce panelists, and solicit public comment. Staff will present a draft outline of workforce issues, including a new workforce element as required by Senate Bill (SB) 589 (Hueso, Chapter 732, Statutes of 2021), for the second AB 2127 assessment and seek public feedback.
