In accordance with the California Energy Commission's *Instructions for Electric Transmission-Related Data Collection*, Publication Number: CEC-200-2022-004, dated July 2022, the City of Riverside (Riverside) provides the following information:

Riverside is a member of the California Independent System Operator (CAISO). On January 1, 2003, Riverside turned over operational control of its transmission entitlements to the CAISO and became a Participating Transmission Owner (PTO). As such, Riverside obtains all its transmission requirements from the CAISO and defers evaluation of bulk transmission needs to the CAISO's annual Transmission Planning Process.

Riverside does have a transmission project moving forward called the Riverside Transmission Reliability Project (RTRP). This project will give Riverside a second point of interconnection with the CAISO through Southern California Edison's (SCE) system at Mira Loma. RTRP has been approved in a prior CAISO transmission planning cycle and is referenced in the CAISO's *Board Approved ISO 2021-2022 Transmission Plan*<sup>1</sup>, dated March 17, 2022. Additional information about this project can be found on the Riverside<sup>2</sup>, SCE<sup>3</sup>, and California Public Utilities Commission<sup>4</sup> websites.

As of the filing of this statement, Riverside does not have any resources or contracts that require new or upgraded transmission.
