The California Energy Commission (CEC) will host a remote-access workshop to present assessments of Southern California Gas (SoCalGas) system reliability for Winter 2022-23. This workshop supports the Order Instituting Information Proceeding for Gas Decarbonization (Gas Decarbonization OIIP).

Vice Chair Siva Gunda is CEC's Lead Commissioner for this Informational Proceeding.

This will be a remote meeting with public access online or by phone through Zoom. A quorum of commissioners may participate, but no votes will be taken.

The public can participate in the workshop consistent with the attendance instructions below. The CEC aims to begin promptly at the start time posted and the end time is an estimate based on the proposed agenda. The workshop may end sooner or later than the posted end time depending on various factors.

Agenda

Staff from the CEC, the California Public Utilities Commission (CPUC), and SoCalGas will present their respective analyses of SoCalGas system reliability for Winter 2022-23. The findings of these analyses will inform the energy agency planning under different winter and gas system scenarios.

Background

The CEC's Gas Decarbonization OIIP, adopted in March 2022, continues dialogue on California gas planning topics, identifies goals for improved analytical capabilities and begins carrying out the 2021 IEPR recommendations for achieving California's climate goals. The OIIP is intended to foster interagency collaboration with the CPUC, the California Air Resources Board, the California Independent System Operator, and other state agencies, as well as the various stakeholders with an interest in gas decarbonization issues. The CEC held a workshop on June 3, 2022, to launch the OIIP and set the stage for future gas decarbonization analysis. The presentations at this workshop will contribute to the dialogue on gas planning while demonstrating CEC staff progress in improving its analytical capabilities in this area.
