Her litigation team blocked Valero's proposed acquisition of a strategic Bay Area storage facility in 2017, and is currently pursuing litigation against two energy trading companies for price manipulation.

In 1999-2000, Borenstein was a member of the California Attorney General's Gasoline Price Task Force. In 2014, he was appointed to the California Energy Commission's Petroleum Market Advisory Committee, which he chaired from 2015 until the Committee was dissolved in
