The proposed solicitation will support research efforts addressing the environmental effects of hydropower operations on downstream ecosystems will contribute to implementation of the Electric Program Investment Charge (EPIC) 2021-2025 Investment Plan.

### **Background**

More than 260 hydroelectric power projects are distributed throughout California's major rivers and streams. All non-federal hydropower projects in California are subject to licensing by the Federal Energy Regulatory Commission (FERC). These licenses are for either 30 or 50 years. More than 50 permitted facilities, representing 2,471 MW in aggregate, will begin the relicensing process in the

next 13 years. The FERC relicensing process is a complex procedure generally taking five years or more to complete. Relicensing requires multiple the participation of numerous

Research from the proposed solicitation will provide better information and tools to reduce the environmental effects of hydropower operations while ensuring the adaptive, proactive management of hydropower as part of California's resilient renewable generation portfolio.
