The applicant cites California Code of Regulations, title 20 section 2505(b) as the basis for confidentiality. Section 2505(b) states:

When another federal, state, regional, or local agency or state-created private entity, such as the California Independent System Operator, possesses information pertinent to the responsibilities of the Commission that has been designated by that agency as confidential under the Public Records Act, or the Freedom of Information Act, the Commission, the executive director, or the chief counsel may request, and the agency shall submit the information to the Commission without an application for confidential designation. The Commission shall designate this information confidential.

LADWP previously designated the highlighted data in the enclosed report as confidential for an indefinite period.

Here, the applicant is a local government agency, has itself designated that the data is confidential under the Public Records Act, and the information submitted is pertinent to the responsibilities of the CEC. Therefore, the CEC designates the above-described information as confidential indefinitely.

Be advised that under the California Code of Regulations, title 20, section 2506, one may petition to inspect or copy documents that the CEC has designated as confidential. A decision on a petition to inspect or copy records is issued by the CEC's chief counsel. Under California Code of Regulations, title 20, section 2507, the executive director may disclose, or release records previously designated as confidential in certain circumstances, and the CEC may hold a hearing to determine the confidentiality of its records on its own motion or on a motion by CEC staff. The procedures and criteria for disclosing or releasing, filing, reviewing, and acting upon such petitions or motions are set forth in California Code of Regulations, title 20, sections 2506-2508.
