The California Energy Commission (CEC) will host a workshop to discuss the Demand Side Grid Support (DSGS) program and Distributed Electricity Backup Assets (DEBA) program. This information will be used to inform potential modifications to the DSGS program guidelines and the development of the new DEBA program.

A quorum of commissioners may participate, but no votes will be taken. The public can participate in the workshop consistent with the attendance instructions below. ## **Background**

Assembly Bill 205 (Ting, Chapter 61, Statutes of 2022) created the DSGS and DEBA programs as part of the Strategic Reliability Reserve. The DSGS program compensates eligible and enrolled participants for upfront capacity commitments and per-unit reductions in net energy load during extreme events achieved through reduced usage, use of backup generation, or both. On August 10, 2022, the CEC adopted guidelines to implement the DSGS program. Participants enrolled 315 megawatts in the program to help meet grid needs during the September 2022 heatwave. This workshop will discuss lessons learned and inform potential modifications to the DSGS program guidelines.

The DEBA program incentivizes the construction of cleaner and more efficient distributed energy assets that serve as on-call emergency supply or load reduction for the state's electrical grid during extreme events. The CEC may allocate monies for efficiency upgrades, maintenance, and capacity additions to existing power generators, and for deployment of new zero or low emission technologies, including fuel cells and energy storage, at existing facilities. This workshop will inform the development of the new DEBA program.
