The California Energy Commission (CEC) will host a workshop to discuss the Demand Side Grid Support (DSGS) program's draft revised guidelines.

A quorum of commissioners may participate, but no votes will be taken. The public can participate in the workshop consistent with the attendance instructions below. # **Background**

Assembly Bill 205 (Ting, Chapter 61, Statutes of 2022) created the DSGS program as part of the Strategic Reliability Reserve. The DSGS program compensates eligible and enrolled participants for upfront capacity commitments and per-unit reductions in net energy load during extreme events achieved through reduced usage, use of backup generation, or both. On August 10, 2022, the CEC

adopted guidelines to implement the DSGS program. On January 27, 2023, CEC program staff conducted a workshop on lessons learned from the program launch and collected public comment. CEC staff has reviewed the comments and will be posting draft revised program guidelines for additional public feedback before the workshop. After further public comments are received, staff will be reviewing and revising as appropriate in anticipation of possible adoption of revised program guidelines by the CEC at a future business meeting.
