 In 2021, the CEC amended the Title 20 data regulations to require underground gas storage operators/owners to submit quarterly data.

- This data will help inform CEC proceedings including the Order Instituting Informational Proceeding for Gas Decarbonization.

- When to file: Quarterly by the following dates (April 15, July 15, October 15, January 15)
- How to file: File forms and declaration page to Dockets 22-OII-02 – Gas Decarbonization.
- **Confidentiality:** Automatic confidential designation if certain conditions are met.
- For what period: Previous quarter except for April 15th submittal, which is previous quarter and calendar year 2022.

## **Questions for CEC**

- Question: CEC-1314 Excel spreadsheet form asks for the "Reservoir Name" on Row 13 of the form. Do we need to copy this tab and have 3 tabs (1 for each reservoir) or can we list all of our reservoirs on one tab with combined daily gas totals?
- **Answer:** We're looking for data on one sheet for the entire project. So when it asks for reservoirs, please list the names of the reservoirs on Row 13 and then put the data for all three on one tab with the combined totals.



# **Questions For CEC (Continued)**

- Question: What do we do about the fuel usage and blowdown quantities for each month?
- **Answer:** Does this gas come out of the working gas total? The forms request the working gas total and the assumption on our end is that reductions to working gas are only from withdrawals. When we think of withdrawals, we think of the number that goes into the utility gas systems from the facility. We also don't request information on gas use by storage facilities operations. However, in order to help us reconcile changes to working gas, you have the option of counting this as part of daily withdrawals or you can provide some kind of footnote indicating the monthly totals.
