Answer: c. More than 3 times per month

 - How do they integrate with your operations? Answer: It is useful to our customers that need the product to be part of the list to be able to get approvals from the utilities.
 - II. How would you describe the value of the lists to your efforts? Answer: It is a comprehensive source of information for stakeholders approving usage of our products. It allows us to sell our products within the state of California and beyond (certain states or utilities also use this list as source of information).
