SB 2 Purpose (signed March 26, 2023)

"From August to October of 2022, Californians experienced some of the highest gasoline prices ever recorded in the state, even though the price of crude oil declined, state taxes and fees remained unchanged, and gasoline prices did not increase outside the western United States."



SB 2 Implementation Activities

- Data Collection & Monitoring
- Refining Margin Establishment Determination
- Penalty & Enforcement
- Fuels Assessment
- Fuels Transition Plan
- Refinery Maintenance Monitoring



Ensuring Robust Stakeholder Engagement

- Stakeholder working groups could include representatives from:
 - Industry
 - Environmental Justice, etc.
- Frequency and structure to be determined



Interagency Coordination

California Air Resources Board (CARB)

- Triennial Assessment will embody CARB's scoping plan as a fuel demand scenario; due January 1, 2024
- Transition Study will be a joint effort with CARB; due December 31, 2024

California Dept of Tax and Fee Administration (CDTFA)

Annual Report to Legislature – due March 1, 2024



Data Collection & Monitoring

Costs vs. Profits

Informs the question of whether a refiner margin should be set

Market Analysis

Informs the question of whether there is market manipulation

Maintenance

Provides insights on timing of planned outages

Other Data

Provides additional insight

Public Process – Outreach, and possibly guidelines or expedited rulemakings



Costs vs. Profits

Data Requirement

Revenue minus Costs = Profits

- 1. Operational cost to produce gasoline PRC 25355 (b)(8)
- 2. Net gasoline profit margin PRC 25355 (b)(9)






Market Analysis

Data Requirement

- 1. Spot Market data (PRC 25354(I))
- 2. System Contracts data (PRC 25354(i)(2)(F))
- 3. Firm Ownership (PRC 25354(b)(7))
- 4. Prices for Product Imports and Production Inputs (PRC 25354(a))

Refinery Maintenance

Data Requirement

- 1. Maintenance Schedules (PRC 25354(m))
- 2. Unplanned Emergency Events (PRC 25354(m)(4))
- 3. Planned Production Levels (PRC 25354(o))
- 4. Permanent Shutdown Notification (PRC 25354(p))





Other Data

Data Requirement

- 1. 96-hour import notice (PRC 25354(j))
- 2. Infrastructure capacity (P RC 25354(b)(2)(4)(5))



Margin Establishment Determination (PRC 25355.5)

- The CEC may set maximum gross gasoline refining margin and penalty **IF**:
 - Consumer benefits exceed costs
- The CEC consider penalty's impact on:
 - Supply/demand challenges
 - Average prices at the pump



State and Local Sales Tax

Environmental Fees

State Excise TaxFederal Excise Tax



Penalty & Enforcement

- Penalties are calculated based on margin
- Penalties are tiered
- Exemptions may be granted
- Penalties go into Price Gouging Penalty Fund
- State audit to begin in 2032



Division of Petroleum Market Oversight

- Led by a director appointed by the Governor
- Provides independent market oversight and analysis
- Advises the Governor and the CEC on fuels pricing and decarbonization
- Will have access to all PIIRA information



Independent Committee

Independent Consumer Fuels Advisory Committee

Eight members total

Six appointed by Governor:

- Academic representative
- Industry representative
- Consumer representative
- Labor representative
- Community, environmental, or environmental justice representative
- Antitrust law representative
- One appointed by the Speaker of the Assembly
- One appointed by the Senate Committee on Rules

Annual Report

- CEC and CDTFA to prepare
 - Reviews gasoline prices and impact on state revenues
- CDTFA may request additional information
 - Penalties up to \$10,000 per day for non-compliance
- Attorney General may request any information collected




Regional Market Concentration **Branded and** unbranded fuels






Possible Gasoline Demand Scenarios

- Aims to ensure adequate fuel supply for Californians
- Requires consultation with fuel producers and a workgroup
- Future joint workshop with CEC and CARB
- Due: December 31, 2024
