As part of the 2023 Integrated Energy Policy Report Gas Demand Forecast process, the California Energy Commission sought from Southern California Gas Company ("SoCalGas") daily gas demand by customer category for the two most recent years, 2021 and 2022 ("SCG\_2023 Forms for Submitting Gas Demand and Rate Forecasting Information, Form 1.4"). Portions of that daily gas demand data is confidential. Previously, SoCalGas submitted substantially similar data to the California Energy Commission which an application for confidential designation was granted by the Executive Director pursuant to section 2505(a)(3)(A). (*See* 11/22/22 CEC letter from D. Bohan to SoCalGas and SDG&E counsel granting confidential designation for daily gas demand data, Docket No. 22-IEPR-03.)

## <u>Certification of Confidentiality by Jungchi Wang Pursuant to Title 20, §2505(a)(4)</u> (Repeated Applications for Confidential Designation)

I, Jungchi Wang, do certify as follows:

- 1. I am a Senior Market Advisor within the Performance Management and Organizational Strategy Department of Southern California Gas Company. I have reviewed the confidential information provided for noncore customers within the SCG\_2023 Forms for Submitting Gas Demand and Rate Forecasting Information, Form 1.4 and am familiar with its contents. I am also familiar with the contents of the previous request for daily gas demand data which was granted confidential designation on November 22, 2022.
- 2. The daily gas demand data being provided here is substantially similar to the previous daily gas demand data that was granted confidential treatment on November 22, 2022. The only differences between the data being provided here and that which was previously requested are: (1) the dates being provided; and (2) the units of measure (to comply with the CEC's request). In addition, the current request seeks data regarding "Core Wholesale and International", "Noncore SMUD Electric Generation", "Noncore Natural Gas Vehicles", "California Exchange Gas" and "Offsystem Deliveries." SoCalGas does not have responsive data for those categories; and, therefore, the undersigned does not have knowledge of these specific data points.
