APPLICATION FOR CONFIDENTIAL DESIGNATION Sutter Energy Center (97-AFC-02C)

CCFC Sutter Energy, LLC (the "Applicant") seeks confidential designation for cultural resources information ("the Information") contained within Appendix C to the *Petition for Modification of the Sutter Decarbonization Project*.

The Information should be kept confidential in its entirety as it contains sensitive information regarding the location of certain cultural resources.
