CCFC Sutter Energy, LLC (the "Applicant") seeks confidential designation for Figure BIO-3, submitted in support of the *Petition for Modification: Sutter Decarbonization Project*, The Information should be kept confidential in its entirety as it contains sensitive information regarding the location of certain special status species.
