Commissioner McAllister and Building Standards Office staff,

Thank you for the opportunity to participate in the 2025 Energy Code (Title 24, Part 6) update. The Statewide Utility Codes and Standards Enhancement (CASE) Team appreciates the California Energy Commission (CEC) providing an opportunity for stakeholders to engage in the pre-rulemaking process for updating the statewide building energy efficiency standards.

The Statewide CASE initiative presents recommendations to support the California Energy Commission's efforts to update California's Energy Code to include new requirements or to simplify or upgrade existing requirements for various technologies. Three California Investor-Owned Utilities (IOUs) — Pacific Gas and Electric Company, San Diego Gas and Electric, and Southern California Edison — and two Publicly Owned Utilities — Los Angeles Department of Water and Power and Sacramento Municipal Utility District — support this effort. The program goal is to prepare and submit proposals that would result in cost-effective enhancements to improve energy efficiency and energy performance, and reduce greenhouse gas emissions reductions in California buildings.
