Background

The 100 Percent Clean Energy Act of 2018 (SB 100, De León, Chapter 312, Statutes of 2018) establishes a target for renewable and zero-carbon resources to supply 100 percent of retail sales and electricity procured to serve all state agencies by 2045. SB 100 requires the CEC, CPUC, and

California Air Resources Board to develop and submit a joint-agency report to the legislature by January 1, 2021, and at least every four years thereafter. The first <u>SB 100 Joint Agency Report</u> (https://www.energy.ca.gov/sb100) was published in March 2021.

To build-off the 2021 SB 100 Joint Agency Report, the CEC, the CPUC, and the CAISO collaborated on an approach to translate the analyses conducted for the report into an <u>SB 100 Starting Point Scenario</u>

(https://efiling.energy.ca.gov/GetDocument.aspx?tn=239685&DocumentContentId=73101) for use by the CAISO in the 20-Year Transmission Outlook.

The objective of CAISO's 20-year outlook is to explore longer term grid requirements and options for meeting the state's greenhouse gas reduction goals. The first 20-Year Transmission Outlook (https://stakeholdercenter.caiso.com/RecurringStakeholderProcesses/20-Year-transmission-outlook) was released in May 2022, and the next 20-Year Transmission Outlook is anticipated in 2024.
