The Applicant seeks confidential designation for the documents outlined in Appendix A (Attachments 1-97).

The cultural resources information (Attachments 1-97) should be kept confidential in its entirety as it contains sensitive and confidential information regarding cultural resources, including tribal cultural resources and archaeological resources.
