#### **Reference: Cultural Responses to CEC Data Request**

Stantec Consulting Services Inc. (Stantec) prepared this memorandum for the Fountain Wind Energy Project (Project). This memorandum includes responses to the California Energy Commission's (CEC) request for information dated February 10, 2023 regarding impacts to cultural resources.

### **DATA REQUEST CUL-003**

These reports are listed in Appendix B, Table 1, of the Administrative Draft of the Fountain Wind Energy Project Cultural Resources Phase 1 Inventory of 4,463 Acres docketed report.
- Provide copies of previous studies that report on any archaeological excavations or architectural • surveys within the literature search area (1 mile buffer from project site).

### **DATA RESPONSE CUL-003**

A records search at the Northeast Information Center (NEIC) of the California Historic Resources Information System (CHRIS) was conducted by NEIC personnel on September 13, 2017 (NEIC File No. D17-150) to obtain and review previous cultural resource records, cultural resource studies, and any additional documentation pertaining to properties located within a 0.25-mile extent of the Survey Area. Full reports were requested as IC File #NE23-64. In addition, a supplemental record search of the Project Site and a 1-mile buffer was initiated on May 16, 2023. The results are discussed in the updated Cultural Resources Phase I Inventory Section 7.1 and Appendix B, Tables 1 and 2

Resources Evaluation Report (HRER) ("fwp\_rpt\_hrer\_submittal\_final\_compiled"). Updated records search, DPRs, and reports are provided (filenames with "NEIC" and "DPR"). Regarding efforts to identify any cultural resources listed or recognized by a city, county, or local historical and archaeological societies or museums, Shasta County does not maintain a historic register nor do the communities on Round Mountain and Burney. An electronic search of the online database of the Shasta Historical Society did not identify any relevant resources.

- Report of Findings (Results): Sketch maps are needed for the following DPR 523 form sets: FW-12, FW-13, FOU0919-2-14, FOU0923-1-2, and FOU1015. See ARMR, p. 12.
- Discussion/Interpretation and Management Considerations (Conclusions): Add discussion that references research design. See ARMR, pp. 15–19.
- References Cited: Include bibliographic entries for all historic maps consulted.

• Please provide a copy of the currently missing Stantec, 2020a. Addendum 1: Update to The Fountain Wind Energy Project Cultural Resources Phase 1 Inventory of 4,463 Acres, Shasta County, California. Prepared for Fountain Wind LLC. March 18, 2020. This will need to be reviewed for adequacy when provided.

# DATA RESPONSE CUL-012

No mitigation measures are proposed to mitigate impacts to historic built resources within the Study Area because the project would not result in any significant impacts to historic built resources. (See Section 8.0 of the HRER ("fwp\_rpt\_hrer\_submittal\_final\_compiled"). Two built historic resources exist within the Study Area: the Pit-Vaca Dixon No. 2 and Pit 1 Vaca-Dixon 230 kV Transmission Lines. The Project would directly impact one historical resource, the Pit-Vaca Dixon No. 2, as well as indirectly impact both historical resources within the Study Area; however, the Project would not result in a substantial adverse change to the integrity of either identified historical resources to the degree that they would no longer be eligible as historical resources pursuant to CEQA. Additionally, no related projects were identified based on publicly available information; therefore, the Project would not contribute to cumulative impacts to historical resources. Therefore, no mitigation is required or recommended.

A redacted, publicly reviewable version of the cultural report is provided.

Please evaluate all highways, roads, and trails in consideration of A Historical Context and Methodology for Evaluating Trails, Roads, and Highways in California, prepared by Caltrans, Sacramento, 2016.
- The applicant may choose to combine the historic built environment inventory report with the Phase 1 cultural resources report and addenda for convenience of use by others and to ensure a comprehensive treatment of all types of cultural resources in the project area.

# DATA RESPONSE CUL3-03

Per CEC's request, an HRER was prepared by an SOIS-qualified architectural historian ("fwp\_rpt\_hrer\_submittal\_final\_compiled"). The Study Area is defined in Section 3.1 of the HRER. It encompasses the Project Site plus a radius of 0.5-miles from proposed wind turbines and aboveground collector lines. The only historic built resources newly identified within the Study Area during the field inspection were roads, specifically SR 299 and logging roads. Built resources not surveyed as part of the field inspection included additional logging roads less than 45 years old. There were no other built resources identified within the Study Area that were more than 45 years old and had the potential to be impacted by the Project. Both SR 299 and logging roads more than 45 years old were evaluated for the National Register of Historic Places and California Register of Historical Resources using the established national and state criteria (see Section 5.1 of the report). The HRER conforms to professional standards and guidelines for architectural history.





Per CEC's request, an HRER was prepared by an SOISqualified architectural historian ("fwp\_rpt\_hrer\_submittal\_final\_compiled"). The Study Area is defined in Section 3.1 of the HRER. It encompasses the Project Site plus a radius of 0.5-miles from proposed wind turbines and aboveground collector lines. The only historic built resources newly identified within the Study Area during the field inspection were roads, specifically SR 299 and logging roads. Built resources not surveyed as part of the field inspection included additional logging roads less than 45 years old. There were no other built resources identified within the Study Area that were more than 45 years old and had the potential to be impacted by the Project. Both SR 299 and logging roads more than 45 years old were evaluated for the National Register of Historic Places and California Register of Historical Resources using the established national and state criteria (see Section 5.1 of the report). The HRER conforms to professional standards and guidelines for architectural history.
