The California Energy Commission (CEC), the California Public Utilities Commission (CPUC), and the California Air Resources Board (CARB) will conduct a joint workshop to discuss findings and recommendations from the 2021 SB 100 Joint Agency Report and the plan to address these findings and recommendations as the 2025 SB 100 Joint Agency Report is developed, as required by Senate Bill (SB) 100 (De León, Chapter 312, Statutes of 2018), the "100 Percent Clean Energy Act of 2018."

The public can participate in the workshop consistent with the attendance instructions below. The CEC aims to begin promptly at the start time posted and the end time is estimated based on the proposed agenda. The workshop may end sooner or later than the posted end time.

Agenda

Staff from the CEC will provide an overview of the last report submitted in 2021 and highlight the developments that have occurred in the last two years, such as new, relevant state and federal policies and programs. Staff from the CEC, CPUC, and CARB will discuss actions taken toward the

SB 100 goals. Several external stakeholder groups will participate in presentations and panels to provide stakeholder perspectives on California's path to the SB 100 goal. Finally, CEC staff will present the proposed 2025 report vision.

There will also be a question-and-answer session, and an opportunity for public comment.

Background

SB 100 requires the CEC, CPUC, and CARB to complete a joint agency report to the Legislature evaluating the 100 percent zero-carbon electricity policy. The requirement is codified in the Public Utilities Code section 454.53, and the full text is available at https://leginfo.legislature.ca.gov/faces/codes_displaySection.xhtml?lawCode=PUC§ionNum=454.53.

The <u>2021 SB 100 Joint Agency Report</u> was published March 15, 2021, and was a first step to evaluate the challenges and opportunities in implementing SB 100. It included an initial assessment of the additional energy resources and the resource building rates needed to achieve 100 percent clean electricity, along with the associated costs. The next SB 100 Joint Agency Report is due to the legislature on January 1, 2025.
