

On behalf of the Imperial County Office of Education (ICOE), I write to express our enthusiastic support of the Elmore North Geothermal Project proposed in Imperial County, California. ICOE serves 16 school districts and 36,249 students in Imperial County. Our mission is to prepare students for life, college, and career. As an organization deeply committed to improving the quality of life in Imperial County, we recognize the significant challenges our community faces.

By generating geothermal energy 24 hours a day, 365 days a year, the Elmore North Geothermal Project will provide critically needed new, renewable baseload generating capacity to support grid reliability and the State's transition to clean, carbon-free electricity.

The Elmore North Geothermal Project will also provide significant economic benefits to Imperial County. Capital expenditures from the project are estimated to bring \$750 million to \$1.3 billion to the local economy, creating over 636 construction jobs and 61 permanent jobs to support maintenance and operation of the facility. In addition to the many jobs that will be created, the project will generate substantial tax revenue and support the local economy through direct purchase of services, supplies, and materials from local and regional companies.
