## COMMENTS:

I recalled hearing that the IID had already allocated 1,500 acre feet (AF) of water for Non-Agricultural projects and contacted Justina Gamboa-Arce of the IID to verify.

On June 25, 2023, Ms. Gamboa-Arce replied by email and provided the following information:

- Per the Interim Water Supply Policy for Non-Agricultural Projects (IWSP), up to 25,000 AF is set aside (not allocated) annually by means of water conservation and is not a reserved amount of water.
- As of July 2023, 5,380 AF has already been committed by water agreement, leaving a balance of 19,629 AF.

Good afternoon Karim,

There is no water "allocated" per say.

Under the IWSP, IID may conserve and set aside up to 25,000 acre-feet annually (AFY) of IID's Colorado River water supply to serve new non-agricultural projects (with water created from IID efficiency conservation projects and programs). The 25,000 acre-feet has been environmentally assessed for potential conservation and is not an actual reserved amount of water supply that currently exists but that can be created when it is needed under this mechanism. As of July 2023, a balance of 19,620 AFY remain available for conservation under the IWSP for new non-agricultural projects (5,380 acre-feet are already under approved water supply agreements).
