The California Energy Commission (CEC) will host a remote-access workshop and will discuss the Gas Research and Development (Gas R&D) Program's proposed energy-related gas research initiatives for fiscal year (FY) 2024-25.

The public can participate in the workshop consistent with the attendance instructions below. The CEC aims to begin promptly at the start time posted, and the end time is an estimate based on the proposed agenda. The workshop may end sooner or later than the posted end time.

Agenda

CEC staff from the Energy Research and Development Division will present the FY 2024-25 research initiative themes in the areas of Gas Decommissioning, Gas System Safety, Renewable Generation, Clean Renewable Hydrogen Distribution, and Building Decarbonization. There will also be an opportunity for public comment. Feedback from the workshop will assist CEC staff in developing the proposed Gas R&D budget plan for FY 2024-25, which will be presented to the California Public Utilities Commission (CPUC) for final approval in March 2024.

Background

In 2004, the CPUC designated the CEC as an administrator for the gas research fund (Decision 04-08-010), which includes surcharges from consumers who receive gas services from public utility gas corporations. This fund supports public interest research and development through the Gas R&D Program. The CEC develops a proposed budget for the Gas R&D Program each year.
