## WILLOW ROCK ENERGY STORAGE CENTER STATUS REPORT NO. 16

Pursuant to the *Order Suspending the Application For Certification Proceeding And Further Orders* docketed August 11, 2023, <sup>1</sup> GEM A-CAES LLC ("the Applicant") hereby submits this status report to inform the Committee regarding the progress of the Application for Certification ("AFC") proceeding for the Willow Rock Energy Storage Center ("Project").

## PROJECT OPTIMIZATION

The Applicant is in the process of preparing a supplemental AFC that incorporates the revised Project Description for the Project and is targeting a filing the first quarter of next year. The Applicant is coordinating closely with California Energy Commission ("CEC") Staff and other stakeholders regarding the optimized Project. The Applicant anticipates consulting with CEC Staff in early 2024 to exchange information regarding the optimized Project in advance of the submission of the supplemental AFC.

Following Status Report No. 15, the Applicant has the following milestones to report:

- Continued participation of Project in additional offtake contracting initiatives, including ongoing discussions through shortlisting in procurement processes with load-serving entities.
- Continued discussions for retail water supply service for both construction and operation, including submission of the initial deposit for water service.
- Continued commercial progress on adaptive reuse of cavern rock. Inclusion of alternate layouts based on adaptive reuse of cavern rock as well as consideration of beneficial reuse to meet regional demand.
- Continued engagement with stakeholders regarding the Project.

The Applicant will continue to file Status Reports on or before the 26<sup>th</sup> of each month with an update regarding the Project's status.
