NOTICE OF RECEIPT PETITION FOR POST-CERTIFICATION PROJECT CHANGE METCALF ENERGY CENTER (99-AFC-03C)

On February 9, 2024, the Metcalf Energy Center, LLC, the project owner, filed a Post-Certification Petition for Changes in Project Design, Operation or Performance and Amendments to the Commission Decision (Petition) (<u>TN</u> <u>254434</u>) with the California Energy Commission (CEC) for the Metcalf Energy Center (MEC), pursuant to California Code of Regulations, title 20, section 1769.

The MEC is a nominal 600-megawatt combined-cycle, natural gas-fired power plant. The MEC was certified by the CEC on September 24, 2001, and began commercial operation on May 25, 2005. The facility is located in southern San Jose, Santa Clara County.

SUMMARY OF PROPOSED CHANGES

The project owner is seeking CEC approval of a proposed change in the definition of the term "Gas Turbine Cold Start-Up Period". In September 2023, at the request of the project owner, the Bay Area Air Quality Management District (BAAQMD) reviewed and approved the proposed definition.

REVIEW PROCESS

This petition is reviewed pursuant to California Code of Regulations, title 20, section 1769. The review process includes an evaluation of the effect the change could have on the environment; the project's compliance with applicable laws, ordinances, regulations, or standards; and whether a change to, or deletion of any condition of certification adopted by the CEC in the final decision or subsequent amendments is required.

After staff has completed its independent review and analysis of this petition, the assessment will be published for public review and comment. Included in the staff analysis will be written notice of staff's intent to either process the proposed

changes as a staff-approved project change or schedule it for consideration by the CEC at a regularly scheduled business meeting.
