The California Energy Commission (CEC) and the California Department of Transportation (Caltrans) will host a workshop to discuss development of the National Electric Vehicle Infrastructure (NEVI) Plan Update for 2024. The Plan Update is due on August 1, 2024, to the Joint Office for Energy and Transportation.

Background

The Biden Administration's \$1.2 trillion Federal Infrastructure Investment and Jobs Act (IIJA) of 2021 provides funding for a broad array of infrastructure categories, including roads and bridges, water infrastructure, passenger rail, energy, broadband internet, and transportation electrification. The IIJA includes \$7.5 billion for electric vehicle infrastructure development. The NEVI Formula Funding Program allocates \$5 billion in non-competitive funding to the states over 5 years. The goal is to create a nationwide network of 500,000 high-powered DC fast chargers along the Federal Interstate and National Highway systems. California's share will be \$384 million over 5 years. The IIJA designates state Departments of Transportation to serve as the lead agency; The California Department of Transportation and California Energy Commission are leading NEVI development in California.

This will be California's third NEVI deployment plan. The first two Plans in 2022 and 2023 were readily accepted and approved by the Federal Highway Administration (FHWA) and Joint Office for Energy and Transportation. CEC and Caltrans have released one solicitation and are planning to release the second later this year.

The NEVI Program Guidance requires an updated Deployment Plan to be submitted each year to qualify states for the next round of IIJA funding. This workshop will focus on the key elements of the 2024 Plan Update and provide stakeholders an opportunity to provide comment or recommendations for the 2024 Plan Update.
