California Energy Commission (CEC) Staff will present an overview of the changes proposed to the Demand Side Grid Support (DSGS) Program Guidelines, Third Edition, adopted May 8, 2024, that have been incorporated into the DSGS Program Draft Guidelines, Fourth Edition. Background

Assembly Bill 205 (Ting, Chapter 61, Statutes of 2022) created the DSGS program as part of the Strategic Reliability Reserve. The DSGS program compensates eligible and enrolled participants for upfront capacity commitments and per-unit reductions in net-energy load during extreme events achieved through reduced usage, use of backup generation, or both. On August 10, 2022, the CEC

adopted the Demand Side Grid Support (DSGS) Program Guidelines, First Edition, to implement the DSGS Program. Participants enrolled 315 megawatts in the program to help meet grid needs during the September 2022 heatwave. On July 26, 2023, the CEC adopted the Demand Side Grid Support (DSGS) Program Guidelines, Second Edition, to address lessons learned from the summer 2022 program implementation and bring on more non-combustion resources with expanded and streamlined participation. On May 8, 2024, the CEC adopted the Demand Side Grid Support (DSGS) Program Guidelines, Third Edition, to refine and clarify program requirements, reduce operational complexities, and aim to scale and grow participation from clean resources. CEC staff have prepared the DSGS Program Draft Guidelines, Fourth Edition, for public feedback, and after public comments are received, staff will review and revise as appropriate in anticipation of possible adoption of the revised program guidelines by the CEC at a future business meeting.
