The California Energy Commission (CEC) will host a workshop to provide an opportunity for the public to provide input on transportation fuel prices as required by Public Resources Code Section 25371.1 (d) among the other items presented.

CEC's Energy Assessments Division staff will present on gasoline inventories, production levels, and the work that's been done year-to-date relating to petroleum.

The workshop will include a public comment period.

Background

The Governor signed Senate Bill (SB) X1-2 (Stats. 2023, 1st Ex. Sess.) on March 28, 2023, and it took effect in June 2023. Among other things, SB X1-2 revised and introduced several new petroleum industry reporting requirements, with submittals beginning in July 2023. The new information includes spot market transactions, firm ownership, agreements and contracts, inventory holdings by type, refinery maintenance schedules, a notice of marine vessel imports,

expanded refinery operator reporting, and new pipeline and port operator reporting. This new information provides greater insight into transportation fuel prices and conditions that may lead to price spikes. SB X1-2 also established a requirement for the CEC to prepare a Transportation Fuels Assessment every three years. The CEC published the first such Assessment on August 15, 2024. The CEC is additionally required to provide an opportunity in December of each year for the Public to provide input on transportation fuel prices.
