The California Energy Commission (CEC) will host a workshop to present preliminary findings from the third Senate Bill (SB) 1000 (Lara, Statutes of 2018, Chapter 368) assessment, focused on potential home charging access. The ability to charge an electric vehicle at home provides the convenience, affordability, and reliability that can enable higher electric vehicle adoption to achieve the State's climate action and clean transportation goals. Results from this assessment will help the CEC design charging programs that maximize charging availability for all Californians.

Background

SB 1000 (Lara, Statutes of 2018, Chapter 368) directs the CEC to assess distribution and access of light-duty electric vehicle charging infrastructure to help inform Clean Transportation Program investments and equitable deployment of infrastructure. Staff published an inaugural report, Senate Bill 1000 Report: Increasing Access to Electric Vehicle Infrastructure for All, in December 2020 showing the distribution of public chargers by income level, population density, and

geographical area. In 2022, staff published the second report, Senate Bill 1000 Report: Drive Times to Direct-Current Fast Chargers, which showed average drive times to public direct-current fast charging stations. At this workshop, staff will present updated results from the first two assessments and new preliminary findings of potential home charging access and proximity of public charging to homes without home charging for the third SB 1000 Assessment. The first two reports are available on the <u>SB 1000 webpage</u>, at https://www.energy.ca.gov/programs-andtopics/programs/clean-transportation-program/electric-vehicle-infrastructure. The third report will be published and available at the webpage in Quarter 2 of 2025.
