The California Energy Commission (CEC) will host a workshop to gather feedback from interested members of the public on the Energy Data Analysis Program. This program will allow data firms to act as agents on behalf of the CEC to analyze confidential and other data housed by the CEC. Non-state agency entities, including local governments, would then be able to contract these data firms to have them analyze energy data within their respective jurisdiction or other parameters. This data would be analyzed by the data firm, anonymized, and provided to the participating entity.

The public can participate in the workshop consistent with the attendance instructions below. The CEC aims to begin promptly at the start time posted and the end time is an estimate based on the proposed agenda. The workshop may end sooner or later than the posted end time.

Agenda

CEC staff will provide an overview of the Energy Data Analysis Program, present proposals for requirements, and solicit feedback from workshop participants. The presentation topics will include, but are not limited to:

- Action plan development, including local governments
- Data analytics firm approval process
- Methodology report creation
- Confidentiality requirements

There will also be a public comment period.

Background

The California Energy Commission (CEC) has developed the Energy Data Analysis Program (EDAP) to provide local governments and other entities an avenue to use confidential and other data housed by the CEC. Currently, local governments and possibly others as well, have difficulties in acquiring detailed energy data. In order to assist them in energy planning or other efforts, EDAP will allow local governments and other entities to obtain analysis of confidential and other data by hiring a data analytics firm to review the data as an agent of the CEC. The data analytics firm will need to anonymize the final report or acquire customer consent prior to releasing the final report.

Program participants are proposed to be required to provide an action plan to the CEC, which will outline their data needs, energy goals, and other necessary details. Data analytics firms will need to meet the CEC's agency vetting criteria and attest yearly with the CEC once vetting has been approved. Once this has been completed, data analytics firms will complete an agency agreement with the CEC. The CEC will review the data analytics firm's final methodology report prior to them releasing it to the participating entity. This will ensure that all information provided is properly anonymized or provided with individual customer consent by the data analytics firm. CEC seeks public input on this proposal during the workshop.
