The California Energy Commission (CEC) will host a remote-access workshop to solicit comments on proposed data collection and analysis for the 2025 Integrated Energy Policy Report (2025 IEPR) relating to gas demand and rate forecasting information forms and instructions.

The public can participate consistent with the attendance instructions below. The CEC aims to begin promptly at the start time posted and the end time is an estimate based on the proposed agenda. The workshop may end sooner or later than the posted end time.

### **Background**

The CEC is directed by Public Resources Code, section 25301 to regularly assess all aspects of energy demand and supply to develop energy policies that conserve resources, protect the environment, ensure energy reliability enhance the state's economy, and protect public health and safety. These assessments are the foundation for analyses and policy recommendations to the Governor, Legislature, and other agencies. To carry out these assessments the CEC "may require submission of demand forecasts, resource plans, market assessments, and related outlooks from electric, natural gas utilities, transportation fuel and technology suppliers, and other market participants" (Public Resources Code, section 25301(a)(2)).

In support of the 2025 IEPR proceeding, staff will collect and review gas demand and rate forecast information from California gas utilities and interstate pipeline companies that deliver gas to California or to the California border. The California Code of Regulations (CCR), title 20, section 1314 authorizes the CEC to collect natural gas information from gas utilities that had annual natural gas deliveries of 200 million therms or more in each of the two previous calendar years. The regulations require separate filings for each of the following gas utilities: Pacific Gas and Electric (PG&E), San Diego Gas and Electric (SDG&E), and Southern California Gas (SoCalGas). Further, the interstate pipeline companies that deliver gas to locations in California or to the California border and gas utilities are required to submit a 10-year forecast of energy prices. (CCR, tit. 20, section 1348.) The draft forms and instructions prepared by CEC staff identify the

information gas utilities must submit regarding their demand forecasts; prices; energy efficiency impacts; demand response impacts; procurement of lower carbon fuels; rates and infrastructure; and related information for 2025 through 2040, and historical years 2023 and 2024.

## **Public Comment**

**Oral comments** will be accepted at the end of the workshop. Comments may be limited to three minutes or less per speaker and one person per organization. Depending on the number of members of the public seeking to make a comment, the facilitator may adjust the total time allotted for public comment and the time allotted for each comment. To comment via Zoom, use the “raise hand” feature so the administrator can announce your name and unmute you. To comment via telephone, press \*9 to “raise your hand” and \*6 to mute/unmute.

A workshop administrator will call on you by the last three digits of your phone number. Unmute your phone before introducing yourself and sharing your comment.

CEC staff may, upon the request of public participants who may be absent during the workshop when a matter of interest to them is being discussed, neutrally and publicly read those participant comments into the record during the public comment period. Comments submitted after the workshop starts or that cannot be read within a three-minute timeframe will be filed in the workshop docket.
