The California Energy Commission (CEC) will host a public meeting on the Staff Assessment for the Darden Clean Energy Project, pursuant to Public Resources Code section 25545.7.6. The purpose of the meeting is for CEC staff to present the Staff Assessment, which includes a Draft Environmental Impact Report (Draft EIR), and receive comments on the assessment from interested government agencies, California Native American Tribes, the public, and the project applicant.

The Staff Assessment contains the CEC staff's independent, objective evaluation of the proposed project. The Staff Assessment was filed to the docket on February 18, 2025 (TN 261842) and can

be found on the project's docket California Energy Commission : Docket Log at <https://efiling.energy.ca.gov/Lists/DocketLog.aspx?docketnumber=23-OPT-02>

The information obtained from the public meeting discussions and comments will be a part of the record of the proceeding and will be considered in the preparation of the Updated Staff Assessment, which will include a Final EIR.

The public can participate in the meeting consistent with the attendance instructions below. The CEC aims to begin promptly at the start time posted and the end time is an estimate based on the proposed agenda. The meeting may end sooner or later than the posted end time.

Background

Effective June 30, 2022, Assembly Bill (AB) 205 added sections 25545 to 25545.13 to the Public Resources Code, which expanded the CEC's existing power plant licensing authority by creating the Opt-In Certification Program. This program allows specified clean energy projects to seek consolidated permitting at the CEC until June 30, 2029. These projects include solar photovoltaic electricity generating power plants 50 megawatts (MW) or more, energy storage systems 200 megawatt-hours (MWh) or more, and the electric transmission lines from these facilities to the first point of interconnection (for a complete list of qualifying projects, see Public Resources Code section 25545).

Under this statutory authority, the CEC permit is in lieu of any permit that would normally be required by the local land use authority and most, but not all, state permits. More information about this Opt-in Certification Program can be found at <https://www.energy.ca.gov/programs-and-topics/topics/power-plants/opt-certification-program>.

The Opt-In Certification Program also requires the CEC to be the lead agency under the California Environmental Quality Act (CEQA) and after an application is deemed complete to do the following:

1. Prepare an Environmental Impact Report (EIR).
2. Hold public meetings as close as practicable to the proposed project site.
3. Consult with California Native American Tribes that are culturally and traditionally associated with the geographic area of the proposed site.
4. Certify compliance with requirements for community benefits agreement, project labor agreements, and economic benefits.
5. Determine whether to approve or deny the proposed project at a publicly noticed business meeting within 270 days unless certain extensions apply.

On November 9, 2023, IP Darden I, LLC and Affiliates (applicant) filed an opt-in application for a proposed solar facility, battery energy storage system, and hydrogen facility in western Fresno County, near Cantua Creek. Consistent with Public Resources Code section 25545.4, CEC staff reviewed the application materials within 30 days and on December 11, 2023, the CEC's Executive Director notified the applicant that the application was incomplete, identifying numerous specific instances where information required under California Code of Regulations, title 20, section 1877 was missing. Over the following ten months, the applicant submitted the missing information. On September 19, 2024, staff determined that the supplemental information required to complete the application was acceptable and issued a Determination of Completeness signed by CEC's Executive Director. On September 23, 2024, staff submitted to the State Clearinghouse, mailed to local agencies, and posted a Notice of Preparation of a Draft EIR to the project's docket. As required by California Code of Regulations section 1880, the CEC hosted an Environmental Scoping and Informational Meeting on October 16, 2024, in Coalinga, California. In October 2024, the applicant removed the hydrogen facility from the proposed project and in December 2024, the option 2 location of the substation, battery, and operations & maintenance facility was removed from the proposed project and therefore those portions of the initial application were not considered or reviewed by CEC.

Project Summary

The applicant proposes to construct and operate the Darden Clean Energy Project on approximately 9,500 acres in western Fresno County. The project consists of a 1,150-megawatt (MW) solar photovoltaic (PV) facility, an up to 4,600 megawatt-hour battery energy storage system (BESS), a 34.5-500 kilovolt (kV) grid step-up substation, a 15-mile 500 kV generation intertie (gentie) line, and a 500 kV utility switchyard. The project would interconnect to the existing Pacific Gas and Electric Company (PG&E) Los Banos-Midway #2 500 kV transmission line. The project would be located in an agricultural area of unincorporated Fresno County south of the community of Cantua Creek.

The solar PV facility would be made up of approximately 3,100,000 solar panels, inverter-transformer stations, and an electrical collection system, and would be located on approximately

9,100 acres of lands currently owned by Westlands Water District that would be purchased by IP Darden. The 500 kV gen-tie line would be sited within an approximate 200-foot-wide easement on private lands. Following the construction of the utility switchyard by IP Darden, ownership and operations of the switchyard would transfer to PG&E. The BESS would be capable of storing up to 1,150 MW of electricity for four hours (up-to 4,600 MWh).
