The California Energy Commission (CEC) has received California Department of Water Resources' (applicant) repeated application for confidential designation, dated June 16, 2025 (TN 264274), for the following:

 Designated information included in the 2025 Electricity Demand Forecast Forms

The applicant states that these records were previously determined by the CEC's executive director to be confidential for three years (TN 251169). The applicant asserts, under penalty of perjury, that the 2025 Electricity Demand Forecast Forms contain information that is substantially similar to previously submitted information that was granted confidential designation, and all facts and circumstances relevant to the confidentiality of the information remain unchanged.

California Code of Regulations title 20, section 2505(a)(4) provides:

If an applicant is seeking a confidential designation for information that is substantially similar to information that was previously deemed confidential by the Commission pursuant to section 2508, or for which an application for confidential designation was granted by the Executive Director pursuant to subdivision (a)(3)(A) of this section, the new application need contain only a certification, executed under penalty of perjury, stating that the information submitted is substantially similar to the previously submitted information and that all the facts and circumstances relevant to confidentiality remain unchanged. An application meeting these criteria will be approved.

The applicant has met the requirements for confidential designation of the above information as a repeated application. Confidentiality is granted for three years,

under the same terms as those in the CEC's Response Letter to CA Department of Water Resources, docketed July 26, 2023 (TN 251169).
