Pursuant to Title 20, section 2505(a)(4), of the California Code of Regulations, Los Esteros Critical Energy Facility, LLC, on behalf of Tanager Power, LLC, hereby submits this Repeated Application for Confidential Designation for the following information requested by California Energy Commission Staff in Data Request Set 3, Data Requests A64 and A65 related to Air Quality and Public Health.¹ Specifically, as set forth in the project owner's Data Response Set 3C, the following information is provided pursuant to this Application:

- Confidential Attachment DR-A64: Electronic calculation spreadsheets that are the basis of the emission calculations, AERMOD input/output files and other electronic support data, provided to CEC Staff via *Kiteworks* or *One Drive* link.
- Confidential Attachment DR-A65: Technical Memorandum Emission Factors for Select Compounds Formed from Thermal Runaway and Fires from LFP Batteries.

By letter dated November 10, 2025, pursuant to Title 20, section 2505(a)(3)(A), of the California Code of Regulations, the Executive Director approved the initial request for confidential designation of certain information relating to the UL9540A Reports, Battery energy storage system fire test reports related to the potential for thermal events.³

Because the information listed above contains information that is substantially similar to, and in some instances derived from, the previously submitted sensitive trade secret information related to the potential for thermal runaway, and all facts and circumstances relevant to the confidentiality of the information remain unchanged, the Applicant is submitting this repeated application.
