Dear Commissioners Pernell and Boyd:

Inland Empire Energy Center, LLC (IEEC) filed the seventh status report, covering actions through December 2002, with the California Energy Commission (Commission or CEC) on January 9, 2003. Our efforts since then have focused on issuance of the Final Determination of Compliance (FDOC) by the South Coast Air Quality Management District (South Coast).

The FDOC was issued by South Coast on February 28, 2003. In the CEC Staff's last status report, Staff stated that it expects to publish the Final Staff Assessment within 30 days of South Coast's issuance of the FDOC. Based on this plan, we request that the Committee schedule:

- ◆ A Pre-Hearing Conference the week of April 7, 2003
- ◆ Evidentiary Hearings starting the week of April 21, 2003
