Project Location: The project will be located in an industrially-zoned area four miles west of the downtown portion of the City of Turlock, in Stanislaus County, California.

Project Description:

The project is a 250-megawatt, combined-cycle power plant, on a 18-acre site within a 69-acre parcel. The project will consist of two combustion turbine generators equipped with dry, low oxides of nitrogen combustors; two heat recovery steam generators; one condensing steam turbine generator; a deaerating surface condenser; a five-cell mechanical-draft cooling tower; and associated support equipment providing a total nominal generating capacity of 250 megawatts. Natural gas for the facility will be delivered via 3.6 miles of new 8-inch pipeline that will connect to the existing Pacific Gas & Electric Line 215 gas-transmission pipeline. The power plant will be connected to Turlock Irrigation District's existing electric system at the power plant site.

On February 18, 2004 the California Energy Commission approved the above-described project pursuant to a regulatory program certified by the California Secretary of Resources under Section 21080.5 of the California Public Resources Code.

1. The project will not have a significant effect on the environment.
2. Mitigation measures were made a condition of approval of the project.
3. A statement of Overriding Considerations was not adopted for the project.
