

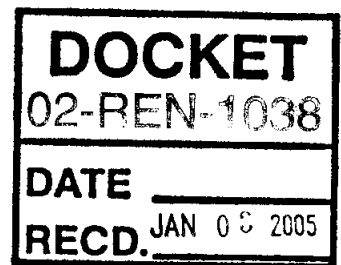

As part of the January 19, 2005, Business Meeting, the Energy Commission will consider adopting revisions to the *Guidebook for the Emerging Renewables Program (Guidebook)*. This *Guidebook* was initially adopted in February 2003, and later revised in December 2003, May 2004, and June 2004.

The Energy Commission's Renewables Committee recommends these *Guidebook* revisions pursuant to Public Resources Code section 25747, which authorizes the Energy Commission to adopt substantive changes to the *Guidebook* upon providing 10 days written notice. Changes shall take effect once approved at a publicly noticed meeting.

Public comments were solicited on the draft *Guidebook* revisions as part of a committee workshop held on December 1, 2004. The Committee has considered these public

comments in recommending the proposed *Guidebook* revisions. In summary, these proposed revisions would address the following:

- Implement a \$10 million Pilot Performance-Based Incentive program to be administered concurrently with the current rebate program.
- Establish a test protocol for eligible inverters to require that each model of inverter be tested and verified for ratings by a qualified Nationally Recognized Test Laboratory to verify the inverter's ratings.
- Eliminate time extensions for all applicants submitting reservation requests after the adoption date of the proposed *Guidebook* revisions.


