The Coalition For A Safe Environment has reviewed the proposed amendments and found that the CEC staff has done an excellent job in updating the regulations, we support the revised Petroleum Industry Information Reporting Regulations as amended on condition that no past or proposed Petroleum Industry reporting requirement is eliminated or requirement diminished.

Should there be a significant Petroleum Industry reporting request change that CEC is considering, we request that a new public hearing be held to address said changes to the regulations prior to any approval or recommendation for approval.

We further wish to state that CEC Public Notification Time and Public Comment Period are insufficient for the public and public advocacy non-profit organizations to properly review CEC documentation, proposed actions and prepare appropriate public comment.

On behalf of the Public's Interest we request that there be a 90 advance notification period and a 90 public comment period for every CEC Public Hearing, Public Meeting, Rulemaking Proceeding, Board Commission Meeting etc.. The significant impacts of CEC decisions on the Public warrant that the public have sufficient time to assess all impacts of CEC decisions, consult experts and time to prepare appropriate comment.

The Coalition For A Safe Environment is a non-profit community organization composed of residents, senior citizens, homeowners, students, non-profit organizations, community organizations, committees, business owners, harbor area employees and friends who are concerned with environmental, economic, health, safety and public welfare issues affecting our communities.
